With Version 4.04, AccuFund Adds Integrated Time Clocks and Improved Time Entry as Well as the Ability to Schedule Reports to Run At Any Time

The Payroll module also now provides the ability to do automatic accrual at month's end when a payroll period overlaps the next month or year. Payroll additionally enables employees to include a memo on their timesheets explaining the work they did, the specific job they performed or why they worked overtime.
